

CONDITIONS OF PARTICIPATION IN THE «DOUBLE CASHBACK – AUTUMN 2026» PROMOTION

Please note that this offer is available exclusively to clients who receive this communication directly from Cornèrcard.

Registration: To take part in this promotion, you must confirm your participation during the promotional period from 1 September 2026 to 31 October 2026 by clicking the «Activate now» button in the communication received from Cornèrcard. Alternatively, if you received this offer by post or via a push notification in the iCornèr App, you can activate this promotion by visiting the website indicated, entering the participation code you received in the communication along with your e-mail address and clicking «Activate». If you received the offer by e-mail as well as by post and/or via a push notification, you just need to register either by clicking the button in the e-mail or on the website.

Transactions:

If you pay at least twice with your Cornèrcard in each week throughout the entire promotional period from 1 September 2026 to 31 October 2026, you will receive double cashback on all transactions in Swiss francs (1.8% cashback instead of 0.9% with Cornèrcard Platinum cards, 1.2% instead of 0.6% with Cornèrcard Gold/Diners Club Gold cards and 0.6% instead of 0.3% with Cornèrcard Classic cards) and for transactions in foreign currency (3.4% cashback instead of 1.7% with Cornèrcard Platinum cards, 2.4% instead of 1.2% with Cornèrcard Gold/Diners Club Gold cards and 1.2% instead of 0.6% with Cornèrcard Classic cards).
