Alternatively, if you received this offer by post or via a push notification in the iCornèr App, you can activate this promotion by visiting the website indicated, entering the participation code you received in the communication along with your e-mail address and clicking «Activate». If you received the offer by e-mail as well as by post and/or via a push notification, you just need to register either by clicking the button in the e-mail or on the website.

Transactions:
